Explanatory notes

Corporation fee

The corporation fee applies to all organisations defined as a **corporation** by section 57A of the [Corporations Act 2001](#). Corporations that lodge an application with the incorrect fee will be contacted and will be required to pay the correct fee.

Reduced or concession fee

The reduced or concession fee applies to eligible pensioners or individuals in receipt of a grant of legal aid or assistance from a community legal centre. The concession rate is set at 25% of the full fee (rounded up or down to the nearest whole dollar amount).
